2009-2010 Professional Judgment Request - *Dependent Students*

In order to have your financial aid application reconsidered using your parent(s) estimated 2009 income instead of actual 2008 income, you must:

1. Complete your financial aid file as required using 2008 income information.
2. Submit a signed copy of your and your parents' 2008 Federal income taxes (1040, 1040A, or 1040EZ and all W-2's) along with an Dependent Verification Worksheet.
3. Give reason for the request on the back of this form.
 - If a parent earned money in 2008 but is now unemployed, you must submit a **letter on company letterhead stating the exact date of termination**, and submit a **copy of the final check stub**. If your parent is receiving unemployment benefits, due to a layoff, you must submit a **benefit payment history statement**. This form can be obtained from the Employment Security Commission.
 - If you are requesting a special condition due to high medical bills, you must submit a **copy of each bill your parents have paid out of pocket**, or a **copy of the receipt received when each bill was paid**, or a **copy of the insurance EOB** (explanation of benefits). These must be dated to coincide with the academic year.
4. Complete this form attaching written documentation for every reason that you have mentioned on the back side of this form. **IF A REASON IS STATED BUT NO DOCUMENTATION IS ATTACHED, THE REASON CANNOT BE CONSIDERED IN RECALCULATION OF YOUR ELIGIBILITY.**
