

## **EXPLANATION OF PHASE III REQUIREMENTS FOR NURSING**

**Please note no extensions will be given for incomplete injection series, titers, or physical forms!**

### **1. NCCCS Student Medical form**

- Blue packet, when turned in we must have the ORIGINAL. We will not accept copies.
- Your provider must fill out and sign the physical exam page.
- The entire blue packet must be filled out. If pages are left blank then it will be returned to you and your medical file will be considered incomplete.

### **2. Two MMR vaccinations or positive titer**

- If you do not have proof of your MMR vaccines, it is suggested that you obtain titer results before receiving the vaccinations again.
- If you have a negative titer, then you will need the two MMR vaccines. They are given a month apart, so it is strongly suggested that you get the first one no later than September 30<sup>th</sup>.

### **3. Two Varicella vaccinations or positive titer**

- If you have had the chicken pox there is a good chance you will have immunity to this virus. You are required to have lab work done that shows a positive titer.
- If you have never had chicken pox or a negative titer, then you will need to have two Varicella vaccinations. They are given a month apart, so it is strongly suggested that you get the first one no later than September 30<sup>th</sup>.

### **4. 2-step Tuberculosis (TB) skin test with results (within the past 6 months)**

- You will need two TB skin tests done. Each test result needs to read within 48-72 hours.
- The second TB skin test needs to be administered **at least** seven days after the first one has been read.

### **5. One dose Tdap or Tetanus booster (within the past 2 years)**

- If you have had a Tetanus booster shot it has to have been administered within the past two years.
- If it has been more than 2 years since the Tetanus has been administered you must have the Tdap done.

### **6. Hepatitis B vaccination series or signed declination waiver**

- There are 3 shots in the Hepatitis B series; we will require a record of the vaccination dates.
- If you are currently in the process of receiving the Hepatitis B series but will not have them completed by the November 15<sup>th</sup> deadline, then you may sign a declination waiver until you complete the series.

### **7. American Heart Association CPR certification**

- Your CPR certification **MUST** be from the American Heart Association. Unfortunately, Health Sciences program cannot accept certification from any other source.

### **8. Verification of Nurse Aide I Certification from N.C. Dept. of Health Service**

- Please visit [www.ncnar.org](http://www.ncnar.org) to print off your Nurse Aide registry. You will have to enter in your social security number and print the verification page.

### **9. Transcript or certificate of completion from nurse aide course**

- We will need a copy of your certificate of completion from a Nurse Aide I course or a transcript showing successful completion (if taken in high school).
