2025-2026 Certification of True, Exact, and Complete Copy of Original Documents (Submission Method – Paper Mail)

Students required to submit U.S. Citizenship/nationality documents must certify they are true, exact, and a complete copy of original documents. For this reason, you must provide to the following to the Office of Financial Assistance and Engagement:

- (a) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a **driver's** license, other state-issued ID, or passport; AND
- **(b)** The original Certification of True, Exact, and Complete Copy of Original Documents form, which must be notarized, along with copies of required U.S. Citizenship/nationality documents. If the notary statement appears on a separate page than the Certification of True, Exact, and Complete Copy of Original Documents, there must be a clear indication that the Certification of True, Exact, and Complete Copy of Original Documents was the document notarized.
